

Privacy Statement

JN Spreads (we/our/us) a trading name of WorldSpreads is a subsidiary of WorldSpreads Group PLC(the Group), and this Privacy Policy provides you with information about the personal data (as defined in the Data Protection Act 1998) the WorldSpreads Group collects from and about you, and what we do with such data in the course of our business dealings with you from the point that you register with our company and use our services, whether in person, by way of telephone, or on-line at, for example, www.xeqtrade.com and/or jnspreads.xeqtrade.com. Use of these websites by you, and the provision of any personal data by you in any other way constitutes acceptance by you of this Privacy Policy and the purposes for which we collect and use personal data, as further described in this Policy and our Terms and Conditions.

Please note that this Policy is in addition to any other use or disclosure, or other relevant information, provided in Our Terms and Conditions. We are committed to complying with the Data Protection Act 1998 and any other applicable data protection laws and regulations in respect of the personal data comprised in the information we collect and use.

JN Spreads collects and stores personal data about you when you contact us, whether this is personally, by phone, email, post over the internet or other electronic medium, and the information collected and stored will include a record of each transaction that you undertake and will also include full details of any card or other payment mechanism that you may offer as payment. Other information is obtained from your completed application and associated form(s) and any conversations we may have with you. We hold personal information in a combination of secure computer storage facilities and paper based files and other records, and take steps to protect the personal information we hold from misuse, loss, unauthorized access, modification and disclosure.

In addition to the personal data, we collect and use details about:

- the products you trade;
- your use of associated risk management tools such as Guaranteed Stop Losses;
- historic profit and losses;
- strategies used by you; and
- open/pending orders.

The personal data collected by WorldSpreads will be used for the following main purposes:

- To determine whether to establish an account for you/or to manage your account, including freezing, suspending or closing accounts;
- To produce a current and accurate customer profile; and
- To provide information on products and services.

We share such details with any other company within the Group as well as with any third party who introduced you to us and/or with whom you have a relationship including any introducing broker. This is in addition to any other disclosures of personal data are described in our Terms and Conditions.

We also share aggregated information with other third parties with whom we have a business relationship, having taken reasonable technical and practical steps to render such information anonymous, or otherwise effectively de-identified, so that we can disclose such information without disclosing your identity.

We use personal data to provide you with relevant and suitable promotional material in respect of other companies within the Group of companies.

We will not sell or otherwise transfer your details to a third party for their marketing purposes.

The global nature of our business and the electronic and automated systems and applications we use to collect and process personal information necessitate the transmission of data on an international basis, involving the transfer of personal data to countries outside the European Economic Area, which may not have data protection laws as stringent as those in the United Kingdom and other European countries.
